- Definitions

 "Goods" means all Goods or Services supplied by the Seller to the Buyer at the Buyer's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).

 "Equipment" means all Equipment including any accessories supplied on hire by the Seller to the Buyer (and where the context so permits shall include any supply of Services). The Equipment shall be as described on the invoices, quotation, authority to hire, or any other work authorisation form provided by the Seller to the Buyer.

 "Price" means the Price payable for the Goods as agreed between the Seller and the Buyer in accordance with clause 4 below.

 Acceptance
 The Buyer is taken to have exclusively accepted and is immediately bound, jointly and severally, by these terms and conditions if the Buyer places an order for or accepts delivery of the Goods/Equipment.
 These terms and conditions may only be amended with the Seller's consent in writing and shall prevail to the extent of any inconsistency with any other document or agreement between the Buyer and the Seller.

 Change in Control
 The Buyer shall give the Seller not less than fourteen (14) days prior written notice of any proposed change of ownership of the Buyer and/or any other change in the Buyer's details (including but not limited to, changes in the Buyer's name, address, contact phone or fax number/s, or business practice). The Buyer shall be liable for any loss incurred by the Seller as a result of the Buyer's failure to comply with this clause.

 Price and Payment

 At the Seller's sole discretion the Price shall be either:

 (a) as indicated on any invoice provided by the Seller to the Buyer; or

 (b) the Seller's quoted price (subject to clause 4.2) which will be valid for the period stated in the quotation or otherwise for a period of ninety (90) days; or

 (c) price ruling at the date of delivery/collection.

 The Seller reserves the right to change the Price if a variation to the Seller's quotation is requested. Any variation from the plan of scheduled works or specifications (including, but not limited to, any variation due to fluctuations in the currency exchange rate or as a result of increases to the Seller in the cost of materials and labour) will be charged for on the basis of the Seller's quotation and will be shown as variations on the invoice. Payment for all variations must be made in full at their time of completion.

 At the Seller's sole discretion a non-refundable deposit may be required.

 Time for payment for the Goods/Equipment being of the essence, the Price will be payable by the Buyer on the date/s determined by the Seller, which may be:

 (b) thirty (30) days following the end of the month in which the goods/equipment were considered.

 (c) the date specified on any invoice or other form as being the date for payment. Payment may be made by cash, cheque, bank cheque, electronic/on-line banking, credit card [plus a surcharge of up to three percent [394-65T] of the Price for AMEXcards and one-point-three percent [134-65T] of the Price for ay other cards), or by any other method as agreed to between the Buyer and the Seller.

 Unless otherwise stated the Price does not include GST. In addition to the Price the Buyer must pay to the Seller an amount equal to any GST the Seller must pay for any supply by the Seller under this or any other agreement for the sale of the Goods/hire of the Equipment. The Buyer must pay GST, without deduction or set off of any other amounts, at the same time and on the same basis as the Buyer pays the Price. In addition the Buyer must pay any other taxes and duties (including, but not limited to, customs duty, packaging costs, freight charges or bank charges) that may be applicable in addition to the Price except where they are expressly included in the Price.  6.1 Risk of damage to or loss of the Goods passes to the Buyer on Delivery and the Buyer must insure the Goods on or before Delivery.
 6.2 If any of the Goods are damaged or destroyed following delivery but prior to ownership passing to the Buyer, the Seller is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries.
 6.3 If the Buyer requests the Seller to leave Goods outside the Seller's premises for collection or to deliver the Goods to an unattended location then such Goods shall be left at the Buyer's sole risk.

 (d) not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods/Equipment in favour of a third party without the prior written consent of the Seller;

 (e) immediately advise the Seller of any material change in its business practices of selling Goods which would result in a change in the nature of proceeds derived from such sales.

 The Buyer waives their rights to receive notices under sections 95, 118, 121(4), 130, 132(3)(d) and 132(4) of the PPSA.

 Unless otherwise agreed to in writing by the Seller, the Buyer waives their right to receive a verification statement in accordance with section 157 of the PPSA.

 or other assets capable of being charged, owned by the Buyer either now or in the
 future, to secure the performance by the Buyer of its obligations under these terms
 and conditions (including, but not limited to, the payment of any money).
 The Buyer indemnifies the Seller from and against all the Seller's costs and
 disbursements including legal costs on a solicitor and own Buyer basis incurred in
 exercising the Seller's rights under this clause.
 The Buyer irrevocably appoints the Seller and each director of the Seller as the
 Buyer's true and lawful attorney/s to perform all necessary acts to give effect to the
 provisions of this clause 9 including, but not limited to, signing any document on the
 Buyer's behalf.

 Defects, Warranties and Returns, Competition and Consumer Act 2010 (CCA)

 The Buyer must inspect the Goods/Equipment on delivery and must within seven (7) days of delivery notify the Seller in writing of any evident defect/damage, shortage in quantity, or failure to comply with the description or quote. The Buyer must notify any other alleged defect in the Goods/Equipment as soon as reasonably possible after any such defect becomes evident. Upon such notification the Buyer must notify any other applicable State, Territory and Commonwealth Law (including, without limitation the CCA), certain statutory implied guarantees and warranties (including, without limitation the statutory guarantees under the CCA) may be implied into these terms and conditions (Non-Excluded Guarantees).

 The Seller acknowledges that nothing in these terms and conditions purports to modify or exclude the Non-Excluded Guarantees.

 Except as expressly set out in these terms and conditions purports to modify or exclude the Non-Excluded Guarantees.

 Except as expressly set out in these terms and conditions or in respect of the Non-Excluded Guarantees, the Seller makes no warranties or other representations under these terms and conditions including but not limited to the quality or suitability of the Goods/Equipment. The Seller's liability in respect of these warranties is limited to the fullest extent permitted by law.

 If the Buyer is a consumer within the meaning of the CCA, the Seller's liability is limited to the extent permitted by section 6A of Schedule 2.

 If the Seller is required to replace the Goods under this clause or the CCA, but is unable to do so, the Seller may refund any money the Buyer has paid for the Goods. If the Buyer is not a consumer within the meaning of the CCA, the Seller's liability for any defect or damage in the Goods is:

 (a) limited to the value of any express warranty or warranty card provided to the Buyer by the Seller in the Seller's liability for any defect or damage in the Goods is:

- manufacture the Goods;
 (c) otherwise negated absolutely.
 Subject to this clause 10, returns will only be accepted provided that:
 (a) the Buyer has compiled with the provisions of clause 10.1; and
 (b) the Seller has agreed in writing that the Goods are defective; and
 (c) the Goods are returned within a reasonable time at the Buyer's cost (if that cost is not significant); and
 (d) the Goods are returned in as close a condition to that in which they were delivered as is possible; and
 (e) the goods were not specifically manufactured for the buyer or a special buy in item i.e non stock list item; and
 (f) the goods are not prefinished aluminium including painted or anodised finishes.
 Notwithstanding clauses 10.1 to 10.8 but subject to the CCA, the Seller shall not be liable for any defect or damage which may be caused or partly caused by or arise as a result of:
- - (c) the Buyer continuing the use of the Goods/Equipment after any defect beca apparent or should have become apparent to a reasonably prudent operator or

- (c) the Buyer continuing the use of the Goods/Equipment after any defect became apparent or should have become apparent to a reasonably prudent operator or user,

 (d) the Buyer failing to follow any instructions or guidelines provided by the Seller,

 (e) fair wear and tear, any accident, or act of Good.

 The Seller may in its absolute discretion accept non-defective Goods for return in which case the Seller may require the Buyer to pay handling fees of up to fifteen percent (15%) of the value of the returned Goods plus any freight costs.

 Notwithstanding anything contained in this clause if the Seller is required by a law to accept a return then the Seller will only accept a return on the conditions imposed by that law.

 Default and Consequences of Default

 Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of one and a half percent (1.5%) per calendar month (and at the Seller's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment.

 If the Buyer owes the Seller any money the Buyer shall indemnify the Seller from and against all costs and disbursements incurred by the Seller in recovering the debt (including but not limited to internal administration fees, legal costs on a solicitor and own Buyer basis, the Seller's collection agency costs, and bank dishonour fees).

 The Buyer understands that the information exchanged can include anything about the Buyer's creditworthiness, credit standing, credit history or credit capacity that credit providers are allowed to exchange under the Privacy Act 1988.

 13.3 The Buyer consents to the Seller being given a consumer credit report to collect overdue payment on commercial credit (Section 18K(1)(h) Privacy Act 1988).

 13.4 The Buyer agrees that personal credit information provided may be used and retained by the Seller for the following purposes (and for other purposes as shall be agreed between the Buyer and Seller or required by law from time to time):

 (a) the provision of Goods/Equipment; and/or
 (b) analysing, verifying and/or checking the Buyer's credit, payment and/or status in relation to the provision of Goods/Equipment; and/or
 (e) enabling the daily operation of Buyer's account and/or the collection of amounts outstanding in the Buyer's account in relation to the Goods/Equipment; and/or
 (e) processing of any payment instructions, direct debit facilities and/or credit facilities requested by the Buyer's account and/or the collection of amounts outstanding in the Buyer's account in relation to the Goods/Equipment.

 13.5 The Seller may give information about the Buyer to a credit reporting agency for the following purposes:

 (a) to obtain a consumer credit report about the Buye

 (d) advice that any overdue accounts, loan repayments, and/or any outstanding

 (g) advice that cheques drawn by the Buyer for one hundred dollars (\$100) or more,
 have been dishonoured more than once;
 (h) that credit provided to the Buyer by the Seller has been paid or otherwise
 discharged.

 4. Building and Construction Industry Security of Payments Act NSW

In the event that Equipment is not returned at all the Seller shall have right to charge the Buyer the full cost of replacing the Equipment.

 (a) keep the Equipment in their own possession and control and shall not assign the benefit of the Equipment nor be entitled to a lien over the Equipment (b) not after or make any additions to the Equipment including but without limitation altering, make any additions to, defacing or erasing any identifying mark, plate or number on or in the Equipment or in any other manner interfere with the Fauipment.

 (c) keep the Equipment, complete with all parts and accessories, clean and in good order as delivered, and shall comply with any maintenance schedule as advised by the Seller to the Buyer. The Buyer accepts full responsibility for the safekeeping of the Equipment and the Buyer agrees to insure, or self insure, the Seller's interest in the Equipment and agrees to indemnify the Seller against physical loss or damage including, but not limited to, the perils of accident, fire, theft and burglary and all other usual risks and will effect adequate Public Liability Insurance covering any loss, damage or injury to property or persons arising out of the use of the Equipment. Further the Buyer will not use the Equipment nor permit it to be used in such a manner as would permit an insurer to decline any claim.

 enforceability of the remaining provisions shall not be affected, prejudiced or
 invalided.

 16.3 Subject to clause 10 the Seller shall be under no liability whatsoever to the Buyer for any indirect and/or consequential loss and/or expense (including loss of profit) suffered by the Buyer arising out of a breach by the Seller is limited to damages which under no conditions (alternatively the Seller's liability shall be limited to damages which under no circumstances shall exceed the Price of the Goods/Equipment hire).

 16.4 The Buyer shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the Buyer by the Seller nor to withhold payment of any invoice because part of that invoice is in dispute.

 16.5 The Seller may license or sub-contract all or any part of its rights and obligations without the Buyer's consent.

 16.6 The Buyer agrees that the Seller may amend these terms and conditions at any time. If the Seller makes a change to these terms and conditions, then that change will take effect from the date on which the Seller notifies the Buyer of such change. The Buyer will be taken to have accepted such changes if the Buyer makes a further request for the Seller to provide Goods/Equipment to the Buyer.

 16.7 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.

 16.8 The Buyer warrants that it has the power to enter into this agreement and has obtained all necessary authorisations to allow it to do so, it is not insolvent and that this agreement creates binding and valid legal obligations on it.
